NOTIFICATION

The Kerala State Road Transport Corporation (KSRTC), invites applications from qualified and competent candidates on contract basis for appointment to the post of **Deputy General Manager (Operations)** at **KSRTC-SWIFT**, the newly proposed profit centre of KSRTC. Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the websites of Kerala State Road Transport Corporation (www.keralartc.com) and Centre for Management Development (CMD), Thiruvananthapuram (www.cmdkerala.net). The details are given below. The online application submission link will open on **06/02/2021 (09:00 A.M.)**. The last date for submitting online application is **15/02/2021 (05:00 P.M.)**.

Note: Candidates will have to upload their updated Curriculum Vitae (CV), passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200 kB and the size of the signature should be less than 50 kB. The CV and the copies of certificates shall be either in JPEG format or in PDF format and each attachment shall not exceed 3MB in size.

General terms and conditions:

- Conditions of experience may be relaxed in the case of exceptionally qualified candidates.
- The candidates should write and speak fluently in Malayalam
- The Posting will be at Thiruvananthapuram; however the candidates shall be willing to be posted anywhere in Kerala and willing to travel extensively through the State and outside.
- Those candidates who are willing to work beyond office hours need only apply.
- The applications shall be accompanied by all the necessary documents to prove identity, qualifications and experience.
- It shall be noted that admittance to various stages of the recruitment will be provisional only, and will not confer any claim unless various other conditions of selection processes are satisfied. Detailed scrutiny of the applications/credentials will be conducted before interview/appointment. Any discrepancy found during the detailed scrutiny will result in the rejection of the candidature.
- KSRTC reserves the right to shortlist only a limited number of candidates for written test/group discussion/interview, as the case may be for the post, based on marks secured in their qualifying examination and/or years of relevant experience. Candidates should clearly mention the marks scored in their qualifying examination in the application. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.
